AAPACN Refer a Friend Campaign Sweepstakes Official Rules

NO PURCHASE OR PAYMENT FROM PARTICIPANT IS NECESSARY TO ENTER OR WIN SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

- **1. GENERAL.** AAPACN Refer a Friend Campaign Sweepstakes (the "Sweepstakes") is a sweepstakes where an eligible entrant will win one (1) prize, as described in more detail below. The foregoing is a general description only of the Sweepstakes and is qualified in its entirety by these Official Rules.
- 2. ELIGIBILITY; BUSINESS RESTRICTIONS. The Sweepstakes is only open to entrants who, as of the entry date, are (a) permanent legal residents of the fifty (50) United States or the District of Columbia, and (b) at least eighteen (18) years old. The Sweepstakes is void outside the fifty (50) United States and the District of Columbia; and where prohibited or restricted by law. HOW TO ENTER;** There is one (1) way to enter this Sweepstakes, in which a friend or colleague that entrant refers to join submits entrant's name in the "Who referred you?" field online, by mail, faxed application, or by verbal dialogue. - **5. A potential winner will be notified by phone and/or email.
- **7. PRIZE.** Subject to the terms and conditions of these Official Rules, one (1) prize will be awarded in this Sweepstakes. The maximum retail value ("MRV") of the one (1) prize is one hundred dollars (\$200.00). A "prize" consists of a pre-loaded Amazon gift card. Prize must be accepted as awarded, and prize is awarded "AS IS" with no warranty, representation, or guarantee, express or implied, in fact or in law, made by AAPACN or for which AAPACN shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE. AAPACN is not responsible for: (a) incorrect or inaccurate transcription of entry information or late, lost, stolen, unintelligible, illegible, damaged, mutilated, altered, incomplete, misdirected or postage-due entries or entries received through impermissible or illegitimate channels, all of which will be disqualified; (b) technical failures of any kind, including but not limited to the malfunctioning of any telephone, computer online systems, computer equipment, website, server provider, network, hardware or software; (c) the unavailability or inaccessibility of any website or service; (d) unauthorized intervention in any part of the entry process or the Sweepstakes; (e) printing, typographical, electronic or human errors which may occur in the offer or administration of the Sweepstakes or the processing of entries; or (f) any injury or damage to persons or property, including but not limited to entrant's computer, which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes, or from viewing, playing or downloading any material from AAPACN's website, regardless of whether the material was prepared by AAPACN or a third party, and regardless of whether the material is connected to AAPACN's website by a hypertext link.
